

Updating Our Constitution

The Purpose of the Constitution

- The constitution...
 - Is our primary governing document (legal).
 - Reflects the theology of the church.
 - Outlines our operational framework.
 - Explains our interdependence between congregations and synods within the ELCA.

Why Update the Constitution?

- ELCA provides and updates a Model constitution every 3 years.
- Our constitution was last updated in 1991.
- There are many changes to the constitution that are reflected in the Model constitution.
- It is in Nativity's interest to maintain an updated constitution for operational and legal reasons.

High Level Overview

- Changes fall generally under 2 categories, those required by the ELCA and the Minneapolis Synod and those drafted by the Nativity working group.
 - Required provisions are preceded by an '*'.
 - There are many new sections to the constitution since it was last updated.
 - Chapters 2 9 and 15 19 are mainly required.
 - Custom sections of the constitution reflect Nativity's culture and our way of operating.
 - Chapters 10 14 contain our updates.
- In addition, bylaws will be incorporated into the constitution itself rather than in a separate document.

Constitution Change Process



- Keith Kendall & Pastor Glenn partnered with ELCA & Council throughout 2021 to draft updates.
 - Introduced to congregation at Annual Meeting 2/13/22
 - Held informational meeting 4/3/22
 - Will hold informational meeting 11/13/22
- Congregational vote planned for Annual meeting Feb. 2023.

Supporting Notes – Page 1

Updated Section	Details & Examples
10.01.01	'Organizations' refers to community partners. Nativity does not exercise oversight of their financials.
10.02	Updates requirement to call a special meeting to 250 voting members. This is for extreme exception cases in which a significant portion of the congregation opposes the direction of the senior pastor or Nativity council (e.g., A group would like to leave the ELCA and the pastor and council refuse to call a special meeting. 250 signatures are required to trigger a special meeting.).
10.04	Simplifies quorum requirements (quorum = 100 voting members)
10.02.01	Encourages participation in the leadership of Nativity (current practice)
12.01.01	Clarifies composition of Executive Committee & maximum council size (current practice)
12.01	Replaces written ballot with voice vote during congregational meetings for the election of council and limits council terms to 6 years (current practice)

Supporting Notes – Page 2

Updated Section	Reasoning & Examples
12.05 & 12.08 (removed)	Recognizes staff responsibilities for day-to-day operations, finances and hiring decisions. Nativity council has financial oversight. Nativity congregation elects a treasurer who serves as CFO of the congregation and reports to the council. Day-to-day operations are managed by the business administrator and senior pastor in collaboration with Nativity Treasurer.
12.06 (removed)	Council does not review members' attendance or engagement at Nativity.
12.10	Supports remote communication and offer a variety of engagement options
13.01, 13.02, & 13.02.01	Reflects Nativity's long-standing process of utilizing short-term task forces to accomplish specific goals
14.01	'Organizations' refers to community partners. Nativity does not exercise oversight of their activities.
14.02	Recognizes the shared responsibility of council & staff for authorizing special interest groups
